**Sub-Inspector in Delhi Police and CAPFs Examination, 2024 – Declaration of result of PET/ PST for appearing in Paper-II – reg.**

Result of Paper-I of Sub-Inspector in Delhi Police and CAPFs Examination, 2024 was declared by the Commission on 02.09.2024, wherein 83614 unique candidates were declared qualified under various lists.

2. Subsequently, Physical Endurance Test (PET)/ Physical Standard Test (PST) of these qualified candidates was conducted by the CAPFs. The summary of result of PET/PST is as follows:
