
The candidates are required to remain present for Interview on the date and reporting time mentioned above, at the **Rajasthan State Judicial Academy, Near Jhalamand Circle, Old Pali Road, Jodhpur (Rajasthan)** with their original documents/certificates for verification. The candidates are **directed to bring all the following original documents** along with two attested/certified photo copies of each document, for verification/perusal. In the absence of original documents, you shall not be allowed to appear in interview and your candidature shall be rejected:

1. Certificate of date of Birth – Birth Certificate or Certificate of Secondary/Higher Secondary/Senior Secondary School having date of Birth issued by recognised Board of Education.
2. Secondary Certificate and Mark Sheet.
3. Hr. Sec./Sr. Sec. Certificate and Mark Sheet.
4. Degree and Mark Sheets of:
B.E./B.Tech/B.Sc. in Computer Science or equivalent degree or Graduate in any subject with PGDCA or A Level course from the Department of Electronics and Accreditation of Computer Classes (DOEACC) or Post Polytechnic Diploma in Computer Applications or 3 years Diploma in Computer Science & Engineering/Computer Applications/ Information Technology or Equivalent from a Polytechnic Institution.
5. Certificate/Document of higher education, if any.
6. Certificate required for seeking reservation in any of the categories – SC/ST/OBC-NCL/MBC-NCL/EWS of Rajasthan.

Caste Certificate of OBC/MBC (Non Creamy layer) must have not been issued prior to one year from the last date of submission of the online application from i.e. 03.02.2024 and in case of OBC/MBC (Non Creamy layer) Certificate is issued between 04.02.2021 to 03.02.2023, an affidavit in prescribed format along with caste certificate has to be produced.

In case of EWS Category, Income and Asset Certificate must be issued for the year 01.04.2023 to 31.03.2024 and in case Income and Asset Certificate is issued between 01.04.2021 to 31.03.2023, an affidavit in prescribed format along with income & Asset certificate has to be produced.

7. SC/ST/OBC-NCL/MBC-NCL/EWS certificate must not have been issued after the last date of submission of the application form i.e. 03.02.2024.
8. Documents related to Divorce (Certified copy of Judgement/Decree, in case of Divorcee), if any.
9. Death Certificate of Husband (in case of Widow), if any.
10. Certificate of Disability issued by competent authority as per relevant rules, if any.
11. Certificate of Ex-servicemen issued by competent authority, if any.

- d. Acquittal for any offence involving moral turpitude or any other offence by a Court of Law, if any;
 - e. Criminal Prosecution pending against you, if any;
 - f. Any charge sheet for committing any offence has ever been filed against you in the Court of Law;
 - g. Negative Final Report concerning you has ever been filed against you in the Court of Law, if any;
 - h. Permanently debarred or disqualified from appearing in any examination, if any;

 4. **you are not having More than two children on/or after the date of commencement of Rajasthan High Court Staff Service Rules, 2002 subject to proviso and explanation of Rule 9 A. (4) of Rajasthan High Court Staff Service Rules, 2002.**
18. Recognised Original photo ID proof (same as uploaded in the online application form).
19. Two recent Passport size coloured Photographs.
20. Certificate of Bonafide Resident of Rajasthan, if seeking reservation in any category.

Notes:-

- a. Please note that no request for any change in the date, time and venue for the Interview will be entertained. In case, you fail to appear for the Interview as per the above schedule, your candidature for the recruitment shall be rejected.
- b. Further, if you try to influence the Recruiting Authority in any way, you may be disqualified for recruitment.

The call letters are being sent to the candidates regarding his/her schedule of the interview by Registered Post/Speed Post on the address provided by them in the on-line Application. **They are, however, directed to appear in the interview as per the above schedule with required documents, mentioned above, even if the registered post/Speed Post does not reach them in time.**
