Phase-XII/2024/Selection Posts Examination [Higher Secondary (10+2) Level posts] – Declaration of Result of Computer Based Examination for shortlisting candidates **for next stage of scrutiny**

Staff Selection Commission conducted Computer Based Examination for **Higher Secondary (10+2) Level** posts under Phase-XII/2024/Selection Posts Examination from 20-06-2024 to 26-06-2024 at various centers all over the country. A total of 10,69,096 completed applications were received for Higher Secondary (10+2) Level posts.

2. Representations received from candidates with regard to Tentative Answer Keys have been carefully examined and the Answer Keys have been suitably modified wherever necessary and finalized thereafter. The final answer keys have been used for evaluation of performance of candidates in the Examination. Final Answer Keys along with Question Papers cum Response Sheets of Computer Based Examination will be uploaded on the website of the Commission shortly.

3. Marks scored by the candidates have been normalized as mentioned in Para 15.3 of the Notice of the examination. Such normalized marks have been used for processing of results to shortlist the candidates for the next stage of Scrutiny.

4. As per Para 19.7 of the Notice of the Examination, candidates scoring minimum qualifying marks in the computer based examination, as given below, have been considered eligible for shortlisting to the next stage of Scrutiny:

5. As per recruitment procedure mentioned at Para-19.8 of the Notice of Examination, 16,162 candidates have been shortlisted for the next stage of scrutiny based on the normalized score and merit of candidates in the Computer Based Examination, in the following ratio:

- (a) 1:30 for vacancies up to 5 (subject to the availability of suitable candidates).
- (b) 1:15 subject to a minimum of 150 for vacancies more than 5 (subject to the availability of suitable candidates).
- (c) For vacancies reserved for PwBD / PwBD-Others / ESM candidates, all the PwBD / PwBD-Others / ESM candidates who are qualifying with minimum-cut-off criteria are to be shortlisted for scrutiny process.

6. Category-wise break-up of the candidates shortlisted in the Computer Based Examination for the next stage of Scrutiny are as follows:

7. Post-Category wise cut-off details of candidates qualified against vacancies for **Higher Secondary (10+2) Level** posts and number of candidates shortlisted, are given in **Annexure-I**.

8. The candidates **who are shortlisted for the next stage of scrutiny as per Annexure-I are required to upload self-attested copies of all the supporting documents** in respect of Educational Qualification (EQ), Experience, Category, Age, Age-relaxation, etc. (as applicable) from **02nd September, 2024 (1100 Hrs)** till **24th September, 2024 (2300 Hrs)** through online web portal **ONLY** by logging in with **their credentials** on the website of the Commission (<https://ssc.gov.in>). **The detailed flowchart/instructions for uploading the documents are given at ANNEXURE-II**. In case of any difficulty in uploading documents online, candidates may call **Toll Free Helpline Number - 1800 309 3063**. The candidates are informed that documents provided through any other mode **will not be accepted** for scrutiny purposes.

9. It may be noted that if a candidate has qualified for multiple categories of posts, then he/ she must upload the requisite documents separately for each category of post.

NOTE:- IF A CANDIDATE DOES NOT UPLOAD THE DOCUMENTS FOR ANY POST CATEGORY(IES), HIS/HER CANDIDATURE WILL NOT BE CONSIDERED IN FURTHER STAGES OF RECRUITMENT FOR SUCH POST CATEGORY(IES). IT MAY BE NOTED THAT AFTER 24TH SEPTEMBER, 2024 (2300 Hrs), THE LINK FOR UPLOADING DOCUMENTS WILL BE DISABLED. NO REQUEST FOR ACCEPTING DOCUMENTS THROUGH ANY MODE WILL BE ENTERTAINED AFTER THE STIPULATED DATE.

10. For the post codes ER10124 & WR13424 of the Higher Secondary (10+2) Level, vacancies are reported only for female candidates.

11. For the post code ER10224 of the Higher Secondary (10+2) Level, vacancies are reported only for male candidates.

12. Para 19.6, para 22 and para 25(h) of the Notice for Examination stated that only one online application was allowed to be submitted by a candidate for one category of post and in case a candidate submits multiple applications for one category of post and appears in the examination (at any stage) more than once for the same EQ Level Exam, his/ her candidature would be cancelled and he/ she would be debarred from the examinations of the Commission as per rules. It was observed that 04 candidates had appeared more than once for the same EQ Level exam. Hence, their candidature has been cancelled. Their Registration Nos. are as given below-

14. Resolution of tie cases - In the event of tie in scores of candidates in the Computer Based Examination, such cases have been resolved by applying the following criteria, one after another, till the tie is resolved, in terms of Para 20 of Notice of the Examination:

- i. Total marks in Computer Based Examination.
- ii. Marks in Part-A of Computer Based Examination.
- iii. Marks in Part-B of Computer Based Examination.
- iv. Date of Birth, with older candidates placed higher.
- v. Alphabetical order of names.

15. Skill Test, wherever prescribed for any category of post(s) will be conducted from amongst the shortlisted candidates whose documents are received and found in order at Scrutiny stage by the User Department(s) / Regional Office(s) of the Commission. Due intimation in advance will be given by the respective Regional Offices to the candidates through their websites.

16. All qualified candidates found clear at the Scrutiny Stage for a particular category of post, will be called for Document Verification (DV) by the Regional Office / User Department to which the Post Category belongs. Accordingly, Admission Certificate for Document Verification will be issued by that Region only.

17. As per Para 19.14 of the Notice of Examination, marks of the candidates will not be disclosed at this stage. The candidature of the shortlisted candidates is provisional.

18. For further stages of recruitment, candidates may visit the websites of the concerned Regional Offices regularly. The websites of the Regional Offices are given at **Annexure-III**.
