- The DSSSB vide its advertisement No.03/23 had advertised total 20 vacancies, Including PwBD-LV-01 (UR- 10, OBC- 05, SC- 02, ST-01 & EWS- 02) for the post of Manager under Post Code- 107/23 in Delhi State Industrial Infrastructure Development Corporation Ltd.
- 2. The written examination (online mode) was conducted on 15.07.2024.
- The marks obtained by 937 candidates who have duly appeared in written examination held on 15.07.2024 have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in
- 4. Based on the performance in the Tier-I written examination (online Mode), a total of 349 candidates who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Tier-II examination, subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier-II examination separately.

- 5. The advertised vacancies are exclusively for EWS/UR/OBC/SC/ST categories only along with horizontal reservation for PwBD-LV sub category and all the candidates of EWS/UR/OBC/SC/ST Categories who secured the marks equal to the cut off marks in each category have been shortlisted for Tier II examination.
- 6. Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Tier-II Examination does not entitle them any right over the post.
- 7. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidate, have been shortlisted against UR vacancies and their final selection to the post shall be

considered in UR Category, subject to availability of vacancies, otherwise for selection in their respective category.

- 8. Further, all the candidates who have scored marks equal to the cut off marks in each category have been shortlisted.
- 9. As per the Board Policy the minimum qualifying marks in one Tier written examination for UR & EWS Category Candidates is 40%, for OBC candidates is 35% and for SC, ST & PwBD candidates is 30%.
- 10. The details of Tier-II examination shall be notified separately by the Board. The candidates are advised to check the Board's website regularly.
- 11. The above short-listing for Tier-II Exam for the post of Manager under Post Code- 107/23 in DSIIDC will be subject to outcome of pending court cases, if any.
- 12. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
